NARRATIVE

On 10/19/2025 at approximately 0953 hours, I, Ofc. Nowicki-Goff #1277, responded to the area of Personal Privacy Williamsburg Ln. for a report of a battery to an ICE Agent.

Upon arrival, I spoke with ICE Agent/supervisor Personal Privacy who advised two of his officers had been battered during their operation.

I spoke with the victims, Confidential Srce) who advised they followed their target suspect Personal Privacy via vehicle, onto Beaconridge Dr. and into the parking lot of Lot P at Williamsburg Ln. Agents Personal and Pers advised Personal exited the vehicle. Upon making contact with Personal Privacy advised he was attempting to take Personal into custody when an altercation arose between them, resulting in Personal being tased. Personal explained that while he was handcuffing Personal, an unidentified female approached and began striking Personal.

Personal advised that she attempted to intervene in the altercation between Personal Privacy and the female subject when another unknown female approached and began hitting Personal in the head with an unidentified object. The females also struck Personal Privacy in the head. Personal and the two females fled the scene on foot and entered the residence at Personal Privacy Williamsburg Ln.

Both females are described as Private approximately 18-20 years old, about 5'3" inches tall, and weighing approximately 110 pounds.

Personal advised he will pursue federal charges, but wanted Bolingbrook Police Department to make contact at the residence in an attempt to identify the females. I attempted to make contact with occupants at the front door but was met with no answer. I provided Personal with a report number and units cleared the scene.

It should be noted that WESCOM advised a return phone call for [Personal Privacy] regarding his [Personal], [Personal Privacy] [Person] advised in summary that [Person] called him via cellphone and explained she had been followed home to the Beaconridge neighborhood by ICE. She related to [Person] that an ICE agent had a gun pointed at her head and was pulling her hair, but did not mention to him any altercation prior. [Person] also mentioned his [Personal Privacy] being present at the time of the incident involving ICE and [Person]. [Person] explained he was not present at the time and had no other information about the event. [Person] was directed to contact the ICE field office for further questions.
